Description of how your charity's programs helped achieve your purpose:

Our charity, Redcliffe Mums, has been committed to supporting disadvantaged members of the community by ensuring children have access to essential school items, helping to remove barriers to education.

Through our ongoing fundraising efforts and community involvement, we have donated to 16 different schools across the City of Moreton Bay. In addition, we've directly supported local students by purchasing school supplies, uniforms, and stationery for families experiencing financial hardship.

We've organised fundraising events and applied for various grants to further expand our reach. As a result, within our partnership with another not-for-profit organisation, we have been able to assist approximately 200 students with back-to-school packs including books, stationery, and school bags.

Collaboration has been key to achieving our mission. We've partnered with other not-for-profit organisations and are proud members of the Redcliffe Community Care Network—a collective of local charities working together to address broader community needs. Through this network, we have helped distribute around 500 Christmas hampers and gifts to families doing it tough during the holiday season.

By remaining connected to the needs of our community and working with others to deliver coordinated support, Redcliffe Mums has continued to deliver real, practical assistance to families, directly aligning with our core aim: supporting vulnerable children to have a fair and confident start to their school year.
