Description of how your charity's programs helped achieve your purpose:

Redcliffe Mums Inc. has remained dedicated to supporting disadvantaged children and families within our community by helping ensure students have access to the essential items they need for education, reducing barriers that can impact learning, confidence, and wellbeing.

Through ongoing fundraising initiatives, strong community support, and local partnerships, we have provided assistance to 16 schools across the City of Moreton Bay. We have also directly supported families experiencing financial hardship by purchasing school uniforms, stationery, school supplies, and other essential items for local students in need.

Throughout the reporting period, we organised a range of successful fundraising events and actively applied for grants to expand our reach and increase the level of support we could provide. Through a collaborative partnership with another not-for-profit organisation, we were able to assist approximately 200 students with back-to-school packs containing books, stationery, and school bags, helping children begin the school year with confidence and dignity.

Collaboration continues to play a vital role in achieving our mission. Redcliffe Mums is proud to work alongside other community organisations and is an active member of the Redcliffe Community Care Network, a collective of local charities committed to addressing broader community needs through shared support and cooperation. Through this network, we contributed to the distribution of approximately 500 Christmas hampers and gifts to local families experiencing hardship during the holiday season.

By staying connected to the evolving needs of our community and working collaboratively with schools, businesses, volunteers, and other organisations, Redcliffe Mums has continued to deliver meaningful and practical support to vulnerable children and families. Our work remains strongly aligned with our core purpose — ensuring every child has the opportunity to start the school year feeling supported, included, and ready to succeed.
